(Licensee), its agents, staff, operators, volunteers and directors and heirs (hereinafter referred to as "Principal Group') herby grants access to private property operated by Principal to enter and participate, in any manner, in the activities and events of said above Principal Groups properties or managed sites and/or being permitted to enter upon, be present at, and use the trails/premises where shooting sports, camping, use off highway/road vehicles or other vehicles, or any other activity (hereinafter known as "Activities") on the said Principals property, the undersigned enters at his/her own risk and on the behalf of his/her personal representatives, heirs, next of kin, and any and all other persons using the premises in any way which includes mere presence on the property. Furthermore, undersigned hold Principal Group, landowner, its agents, staff, operators, volunteers and directors and heirs HARMLESS from any and all injuries, WHETHER CAUSED BY THE NEGLIGENCE OF THE PRINCIPAL GROUP OR OTHERWISE, any accidents, death, liability and responsibility even if at Principals negligence.

I also authorize Principal Group to utilize photos of me, my family and children for promotional use on our web sites and/or marketing material. This waiver is perpetual.

- 1. I Acknowledge rules and regulations for entering private property and will abide by such rules and regulations and pay any fines assessed. Failure to follow rules and regulations will result in removal from private property without any type of refund and possibly being banned from property. Principal does not provide refunds for any reason. Undersigned will report any unsafectivities and/or conditions to staff immediately upon observation and/or discovery.
- 2. Undersigned assumes full responsibility for any and all risk of bodily injury, death, or property damage arising out of or related to the premises or the activities WHETHER CASUED BYTHE NEGLIGENCE OF THE PRINCIPAL GROUP OR OTHERWISE.
- 3. Undersigned ACKNOWLEDGES that the activities conducted on Principal Groups property is dangerous and involves the risk of serious injury and/or death and/or property damage. The undersigned, also expressly acknowledges that human injuries received may be compounded or increased by rescue or first aid from Principal Group, EMS or Fire Department. All accidents or injuries must be reported to park office by calling 830-798-9820. This number is printed on all trail maps.
- 4. Undersigned agrees to not name Principal Group in any subrogation attempt to insurer, health insurance company, underwriter or contractor thereof.
- 5. Undersigned agrees that in the event of any dispute that it will be handled through mediation in Burnet County, Texas.
- 6. Principal Group assumes entrants have had safety training and/or operator training for off road vehicles, firearms and all related outdoor equipment to be used on property. By signing this form, you certify that you have had safety and operator training and/or experience with the equipment that you will be using on Principals property.
